Internal Provinces of New Spain Collection. Papers, 1704–1789. 1 foot.

Spanish colonial governmental unit. Copies of documents (1704–1789) from the Spanish archives of New Mexico relating to Indian relations, military defense, trade, and general colonial conditions in New Mexico, with notes from Ralph Emerson Twitchell's guide, *The Spanish Archives of New Mexico*.

About the collection:

This collection consists of photostatic copies of documents from the Spanish Archives of New Mexico. The documents are arranged chronologically in 9 volumes, and cover the period from 1704-1789. Most of the documents are edicts, reports, correspondence, or civil hearings concerning relations (particularly trade and hostilities) between the Spanish and the Pueblo Indians of the Rio Grande Valley and the Utes, Apache, Navajo, and Comanche. Brief descriptions of the contents of each volume are listed below and have been taken largely from Ralph Emerson Twitchell's guide, *The Spanish Archive of New Mexico* (1914). Numbers appearing in parentheses before each document(s) are catalog numbers as given by Twitchell in his guide.
