Harry A. Stalker Collection

Stalker, Harry A. Papers, 1892–1954. 4 feet.

Physician. General correspondence (1904–1950); a diploma (1896) and medical licenses (1896–1909); notebooks and correspondence relating to his education; and correspondence (1936–1948); printed material (ca. 1910–1950); ledgers (1894–1914); daybooks (1896–1951); and other financial records, all relating to his medical practice and farm in Pond Creek, Oklahoma.
