## University Archives Record Group 59/02 Museum of Natural History: Stovall Museum Collection, 1881-1971 (1.6 cf contained in 4 document cases and 1 flat storage box)

#### **Background:**

The Stovall Museum Collection is a mix of sub-collections acquired and accessioned by the museum between 1956 and 1975. It includes the following:

- The Dr. Owens H. Tilley Papers, 1910-1931 (accession date and number unknown) was transferred by J. K. Greer to the University Archives on January 4, 1978. It includes papers, records, and photo prints belonging to Dr. O.H. Tilley from Quanah, Texas and late of Altus, Oklahoma.
- The following collection and papers were transferred to the University Archives by J. K. Greer on May 25, 1978:
- The Mrs. Ada Martin Collection, circa 1850-1900 (accession number H/56-7/2/) was accessioned on July 24, 1956. A photographic collection consisting of cased ambrotypes, cartes-de-visite with albumen prints, and photo prints.
- The George Sohlberg Collection, n.d. (accession number H/58-9/21/) was accessioned on December 14, 1958. It consists of engraving prints for illustration of Charles Dickens' works.
- The Barbour Collection, circa 1902 (accession number H/58-59/44/) was accessioned on February 12, 1959. It consists of a diagram of the works of an Elgin watch.
- The Lucile Searcy Collection, circa 1850-1900 (accession number H/59-60/1/) was accessioned on September 24, 1959. It consists of one cased ambrotype.
- The D. C. Campbell Collection, circa 1920 (accession number H/62-63/5/) was accessioned on October 9, 1962. It consists of one color print of Columbus in the Santa Maria.
- The Mrs. Y. V. Bowman Collection, circa 1860 (accession number H/64-5/1/) was accessioned on February 26, 1965. It consists of one tintype.
- The Dr. Floyd Edward Warterfield Papers, 1893-1945 (accession number H/65-6/1) was accessioned on September 21, 1965. It includes documentation of his medical education and career which ended in Muskogee, Oklahoma.
- The Mrs. Elizabeth A. West Papers, 1881-1971 (accession numbers H/68/2 and H/72/2/) was accessioned in March 1968 and June 1972. The papers consists of letters, wedding invitations, pamphlets, photo prints and certificates reflection the careers and lives of T.

- J. Laws and spouse, Ada Thompson Laws, of Granite and Blanchard, Oklahoma, and Mr. and Mrs. W. Z. Thompson of Lathrope, Missouri and late of Blanchard, Oklahoma. Elizabeth West was the daughter of Mrs. Thompson and the sister of Ada West.
- The H. K. Lininger, n.d. (accession number H/71/4/) was accessioned in July 1971. It consists of a photo print of an engraving in miniature of the Declaration of Independence.
- The Henry Neal Family Collection, 1899-1900 (Accession number H/75/8/) was accessioned on February 22, 1975. It consists of two volumes of a grocery and dry goods ledger.

#### **Provenance:**

During the course of an inventory of Room 1 and its sub-rooms during 1991, three boxes (2 non-standard and 1 document box approximately 2.6 cubic feet) marked "Stovall Museum Collection" were located. Attached accession reports indicated that two transfers of records occurred (January 4, 1978 and May 25, 1978). Processing was completed May 10, 1993. Upon an initial inventory it was apparent that a number of sub-collections were represented by this collection. During processing these sub-collections were reconstructed and a finding aid was completed on May 12, 1993. Upon the receipt of provenance information and item descriptions from the Collection Manager, Julie Droke, at the Oklahoma Museum of Natural History, this finding aid was revised on June 9, 1993.
