Postal employee and historian. Publications written by Womack, including manuscripts (1982–1984), newspaper clippings (1984), and pamphlets (1981–1983), along with correspondence (1980–1984) and research materials relating to these publications. The research materials include claims (1890–1920); saloon licensing papers (1896–1909); tax levies and assessments (1902–1912); bonds (1906–1912); reports (1902–1910); and related records of Cleveland County, Oklahoma, and its townships and cities.
